# Technical Note IBOR Fallbacks: Revision to Usage Terms

## Restrictions on the 'use' of HKD HIBOR Fallbacks and Related Data

The Hong Kong Treasury Markets Association ("TMA"), through its appointed Calculation Agent and licensing entity, FTSE Russell, an LSEG business, has introduced a commercial policy and licensing arrangements for use of HKD Overnight Index Average ("HONIA"). Consequently, additional restrictions have been placed on the use of Hong Kong Dollar Interbank Offered Rate ("HIBOR") Fallback ("HKD HIBOR Fallback") Rates, the associated Adjusted RFR HONIA ("Adjusted HONIA"), and the Spread Adjustment for HKD HIBOR.

In respect of Adjusted HONIA, such rate may not be used as a fallback or to facilitate transition to alternative reference rates.

Absent an appropriate license in place between a user and FTSE Russell or its affiliates, a user may not use any of the Adjusted HONIA, HKD HIBOR Fallback, or Spread Adjustment for HKD HIBOR as a primary reference rate in a Financial Product.

Updated IBOR Fallback Usage Terms, effective 1<sup>st</sup> November 2024 can be found in the "Resources" section of Bloomberg's LIBOR Transition Solutions web <u>pages</u><sup>1</sup>. For the avoidance of doubt, there are no new restrictions on the use of HKD HIBOR Fallback as a <u>fallback reference rate</u> in a Financial Product, per the Usage Terms.
